Jeanne Milliken Bonds
Professor of the Practice of Public Policy and of Impact Investment, and Sustainable Finance
UNC Kenan Flagler Business School

Jeanne Milliken Bonds is professor of the Practice of Public Policy and of Impact Investment, and Sustainable Finance at UNC Kenan Flagler Business School. She is leading a new initiative, “Invest to Sustain,” to increase community and business capacity to enact social impact investing.

As the former senior leader in Regional Community Development for the Federal Reserve Bank of Richmond, she provided leadership for strategic stakeholder collaboration and community-level solutions, focusing on low- and moderate-income and underserved communities in support of the Federal Reserve System’s Community Development function. During that time, Jeanne led several Federal Reserve System teams, including one focused on the Community Reinvestment Act (CRA) and another on rural policy issues. She has a bachelor’s degree in economics and a Master’s in Public Administration from the University of North Carolina at Chapel Hill.

Jeanne is North Carolina’s recipient of the Council of State Governments’ national Henry Toll Fellowship. She is a former mayor.
